

## **NETA Privacy Policy**

Thank you for visiting the Nebraska Educational Technology Association (NETA) website, [www.netasite.org](http://www.netasite.org), and reviewing our privacy statement. NETA is committed to protecting the privacy of our members and visitors. Our privacy policy is clear: We will collect no personal information about you when you visit our website unless you choose to provide that information to us.

Any information you choose to provide on the website will only be used to provide or improve services. NETA guards your privacy and appreciates your trust.

### **Emails and Web Forms**

Personally identifying information that you provide by emails or web forms will be used only for such purposes as are described at the point of collection, such as to send information or products to you, update your membership record, or to respond to your questions or comments. If you provide contact information, NETA board members or staff may contact you to clarify your comment or question, or to learn about your level of customer satisfaction with our services.

Any credit card information you provide for goods or services is secure and used only for your intended purpose.

### **Information Collected and Stored Automatically**

During your visit to our website, we will automatically gather and store certain information about your visit, but not about you. This information does not identify you personally. We automatically collect and store only the following information about the visit:

- The Internet domain (for example, "xcompany.com" if a private Internet access account, or "aschool.edu" if connected from a university) and IP address (an IP address is a number that is automatically assigned to a computer whenever it is surfing the Web) from which access to our website is gained;
- The type of browser and operating system used to access our site;
- The date and time of access to our site;
- The pages visited and for how long;
- The address of the website from which the initial visit to [www.netasite.org](http://www.netasite.org) was launched, if any.

We use this information to help us make our site more useful to visitors and to learn about the number of visitors to our site and the types of technology our visitors use. The data that is collected is not connected to your personal information or identity.

### **Links to Other Sites**

This website contains links to other sites. The Nebraska Educational Technology Association is not responsible for the privacy practices of other sites, which may be different from the privacy practices described in this policy. We encourage you to become familiar with privacy practices of other sites you visit, including linked sites.

NETA does utilize services from outside vendors to fulfill its objectives of successful online communication. NETA has selected these service providers to accomplish items such as: mobile application development, online payment for conferences and online voting/data collection.

### **Security**

For site security purposes and to ensure that this service remains available to all users, NETA uses software programs to monitor network traffic to identify unauthorized attempts to upload or change information or otherwise cause damage.

Unauthorized attempts to upload information or change information on this service are strictly prohibited and may be punishable under the Computer Fraud and Abuse Act of 1986 and 18 U.S.C. Sec. 1001 and 1030. Information also may be used for authorized law enforcement investigations. Except for the above purposes, no other attempts are made to identify individual users or their usage habits.
